- 2022 Subcommittees There are two proposals for a new structure of subcommittees:
 - 1. PSTAA, Young Leaders, Youth Justice (split into two focus areas)
 - 2. PSTAA, Youth Leaders, Youth Justice, Community Engagement
- Comments:
 - The Community Engagement subcommittee could collaborate well with the other subcommittees as well as hold a space for family/parent/mental health.

OVERSIGHT AND ADVISORY: Best Starts RFP Process - Megan McJennett

- Request for Proposal (RFP)/Request for Qualifications (RFQ)/Request for Applications (RFA) is the King County process for funding organizations. While leading with equity, it is a competitive process that gives all types of organizations and communities opportunities to receive funding without having special connections to the county or "being in the know"
- BSK invests in promotion, prevention, early intervention, and policy & systems change
- Investment amounts for BSK 2.0:
 - o Childcare ~\$200M
 - Capital Projects up to \$50M
 - Capacity Building ~\$10M
 - Homelessness Prevention ~\$22M
 - Investing Early (P-5) 50% of remaining levy
 - Sustaining the gain (5-24) 37% or remaining levy
 - Communities Matter 8% or remaining levy
 - Data and Evaluation 5% or remaining levy

Comments/Questions:

- How does the current data effect the process?
- How is equity determined? What is the outreach process?
 - Every RFP is put out through social media (blog, Facebook, twitter, etc.), board members also forward it out to their networks. BSK works with Language Community Liaisons to help spread the word as well.
 - Look at special populations, geographical and more determinations to ensure that equity is at the forefront
- What is sustaining the gain (systems change)? Is it intentional how systems need to shape themselves in terms of effort to sustaining the gain?
 - There are strategies within each investment area. There are some that focus on direct services, some focus on policy change and some are focused on both. There is also the Communities of Opportunity strategy that looks at the systems from the Cultural and community lens where change is needed.

- You mentioned the original "blank slate" sort of idea of walking around trying to create this process.
 This process is so much more equitable that what preceded at the county. Is the process of developing the RFP process captured so other groups can copy the incredibly learning of this BSK process unfolding?
 - There is an RFP template available but there is a lot of room for customization based on need, strategy, outcome, etc.
