 - Ensure coordination of early care, education, and healthcare systems so they quickly respond to families' needs
 - Strengthen the child services workforce through training and transforming organizations and systems
 - Make developmental screening and services that celebrate developmental progress available and accessible to all families
 - Drive equity by enhancing screening tools, practices, referrals, and services
- Three buckets of Universal Development Screening:
 - Integration into other BSK P-5 Strategies
 - Universal Supports for ALL community providers

- How does mental health show up in this?

- Address both child and parent mental health; depends on role and expertise of the grantees/programs doing the work.
 - Ex. There is a program a program focused on perinatal mood and anxiety orders and they have created a culturally sensitive checklist
- Gender issues that come up in this? What category would
 - Spans over many topics, not just one of the boxes. There is a common screening question that tries to address this, “Can the 3-year-old-self identify as a boy or girl?”
- What’s the youngest age you do screening?
 - 1 month, started in 1998
- How does this support family childcare providers/centers, especially the “mom and pop” ones?
 - Multiple programs service family childcare and childcare programs, also offering partner services where they connect them to access their own programming to access training for this screening
- Do any programs serve homeless families?
 - Not any exclusively
