

## Known and Loved Organization

### Mosaic Pieces of Me Camp Liability Release Form

**PLEASE READ CAREFULLY. THIS DOCUMENT CONTAINS A RELEASE AND WAIVER OF LIABILITY.**

**1. Subject:** Participant and guardian recognize and expressly agree that participating in any adventure, sport, or activity is inherently dangerous. Further, guardian and participant recognize that certain safety precautions are followed, yet following these does not guarantee nor does Known and Loved Organization, guarantee participant's safety.

**2. Waiver and Release from Liability:** Participant and guardian understands that Known and Loved Organization assumes no responsibility for injuries or illnesses that participant may sustain, a.) as a result of participant's health or physical condition, b.) resulting from participant's participation in the activity, c.) as a result of another participant's or third person's actions, or d.) as a result of participant's use of Fellowship Greenville facilities, other locations where camp activities take place in the community, and/or equipment in connection with camp activities. The participant and guardian release and agree to hold harmless, defend, and indemnify Known and Loved Organization and its directors, board members, staff, and supporters from and against any and all claims for personal injury (including loss of life) and all other losses or damages that the participant may suffer as a result of his or her participation and/or enrollment in Known and Loved Organization activities.

**3. Medical Consent:** Participant and guardian grant permission to Known and Loved Organization and its employees and staff to take the participant to a licensed physician for medical treatment, emergency surgery, or hospitalization if participant becomes ill, sustains an injury, or otherwise requires medical treatment or attention and Known and Loved is unable to contact the emergency contact listed by participant. The participant and guardian give consent to any licensed physician to administer drugs or medicine, or to perform such medical procedures as that physician determines necessary for the relief of pain and to preserve the participant's life or health. Participant and guardian further authorize Known and Loved Organization to give first aid, CPR, or other treatment by a qualified staff member to participant.

**4. Property Loss:** Participant and guardian understand and agree that Known and Loved Organization is not responsible for personal property that is lost, damaged, or stolen in connection with this activity.

**5. Binding Effect:** This agreement shall be binding upon participant and guardian, his/her/their heirs, estate, successors, and legal representatives.

**6. Acceptance:** If any portions of this waiver and release are held to be invalid, participant and guardian agree the remaining terms shall continue to be in full legal force and effect. Participant and guardian understand and agree that this waiver and release is binding upon his/her/their heirs, estates, and legal representatives.

**7. Therapeutic Release of Liability:** Participant and guardian understand and acknowledge that this activity is not therapy nor a therapeutic group, and that no client/therapist/physician relationship is formed by participation. The information provided to participant and guardian is educational only and does not constitute the provision of medical, psychological, or other professional health care treatment services.

In exchange for allowing participant and guardian to participate, participant and guardian hereby waive and covenant not to sue, and further agree to indemnify, defend, and hold harmless, Known and Loved Organization and its officers, directors, employees, contractors, and volunteers (collectively, the "Waived Parties"), from any and all liability, claim(s),

demand(s), cause(s) of action, damage(s), loss or expense, including court costs and reasonable attorney's fees of any kind or nature whatsoever (together and separately, "Liability") which may arise out of, result from, or relate to participation. Participant and guardian further agree that if, despite this Agreement, they, or anyone on their behalf, make a claim for Liability against any of the "Waived Parties", participant and guardian will indemnify, defend, and hold harmless the "Waived Parties" from any such Liability which may be incurred as a result of such a claim that participant or guardian might have against the "Waived Parties" or anyone associated with the Known and Loved Organization.

**8. Religious or Faith Based Component:** Known and Loved Organization is founded on principles of the Christian Faith. Such principles, which are disclosed fully at [www.knownloved.org](http://www.knownloved.org) are emphasized in our programming. During the parent/guardian training for Pieces of Me Camp, these principles are discussed with parents/guardians to inform them of the faith based contents of the curriculum. Participant and guardian agree to participate in camp and consent to the religious and faith based components of the program being included throughout.
