- Stopping the School to Prison Pipeline Youth Justice Subcommittee
 - Youth Justice, incarceration, mental health/trauma, education system, workforce/economic strength
 - Look back to know how to move forward, knowing how collective change occurs, know the
 principles of a policy, literacy development, economic development & sustainability, data,
 support systems, community has a place within the schools, study of policy...

- Strengthen Families (Community Engagement Subcommittee/Workgroup)
 - o Problem/Challenge; How to do this as the CYAB? How to tie into YAP update?
 - Future care work, storytelling of CYAB/BSK, family members to host events, invite corporation to the conversation, childcare foundational, places with food, supporting kids, economic, childcare 0-18, support/increase programs that create ways for families to gather, engaging so they can get resources, YouthCare, community schools, culturally, language, mentorships, stipend parent engagement coordinator, economic aspect, what problem are we trying to solve...
- Invest Early & Often & In Outcomes (Puget Sound Taxpayer Accountability Account Advisory Subcommittee PSTAA)
 - o \$318 Million investment over 18 years
 - Budget Driving Investments
 - L&L Pilot Project ending, what is CYAB recommendation? K-12 investments, what is outcome for L&L? Evaluation
 - Budget & Revenue reviews 14 orgs participatory grantmaking L&L
 - Promise learning first year monitor outcomes investment
 - Early learning facilities fund how do we ensure equity investment
 - Structural barriers where are dollars? advisory notes we can be out the box
