

## 2022 NC3 ANNUAL LEADERSHIP SUMMIT TERMS AND CONDITIONS

- I. **PAYMENT:** Each NC3 Leadership School will be provided 2 complimentary registrations as an NC3 Leadership School Membership Benefit. Additional registrants from NC3 Leadership Schools can attend for \$299 USD per person. Non-NC3 Leadership School Members can attend for \$299 USD per registrant. NC3 Global Industry Partners will receive complimentary registration (3 registrants per partner only). Local/Regional Industry Partners or Representatives can attend for \$299 USD per registrant. Event Speakers or Panelists will receive complimentary registration. Upon registration, you will receive an online invoice within 10-14 days. Please pay your invoice directly online using the link provided on the invoice or send payment to NC3, P.O. Box 580802, Pleasant Prairie, WI, 53158. Checks should be made payable to "NC3". If you have any payment questions, please contact Charlene Niewerth at [accounting@nc3.net](mailto:accounting@nc3.net). Payment is due 30 days prior to the event or immediately if registering within 30 days of the event. Payment is non-refundable if cancellations are made within 30 days of the event.
- II. **WAITLIST:** Once this event hits capacity, registrants will be moved to the waitlist. Registrants that are waitlisted will be notified by email. Once a registrant is on the waitlist, they will remain on standby until a spot opens for them at the event. During this time, registrants should not assume they will be able to attend this year's event until directly told so from an NC3 representative. Individuals on the waitlist will be contacted periodically of their standing, but the final call on admittance will be made two weeks prior to the event. Registrants will be offered access to the event in the order that they were placed on the waitlist. Individuals on the waitlist can check in at any time with [ashley.adams@nc3.net](mailto:ashley.adams@nc3.net) to find out their position on the list.
- III. **MEDIA RELEASE:** By registering for the 2022 NC3 Annual Leadership Summit, you hereby consent to participating in interviews, the use of quotes, and the taking of photographs, recordings, movies or videotapes on behalf of the individual who registered for the National Coalition of Certification Centers' (NC3) Annual Leadership Summit. You also grant NC3 the right to edit, use, and reuse said products for nonprofit purposes, including but not limited to use in print, on the internet, and all other forms of media.
- IV. **PRICING AND OTHER ERRORS:** If the amount you pay for your registration is incorrect, regardless of whether this is because of an error in a price posted on the website or otherwise communicated to you, or you are able to register

for this event when it wasn't supposed to be released for sale, then NC3 will have the right to cancel your registration and refund the amount that you paid. This will apply regardless of whether it's due to human error or a transactional malfunction of the website.

- V. **ORDER CONFIRMATION:** If you have not received confirmation of your registration in the form of an email to the address you registered with after 10-14 days of submitting your registration, or if you receive an error message/service interruption while registering, it is your responsibility to confirm with [ashley.adams@nc3.net](mailto:ashley.adams@nc3.net) whether or not your registration was successful. Only you may be aware of problems that occurred during your registration process, and NC3 will not be responsible for any losses if you assume that an order was placed even though you failed to receive confirmation.
- VI. **CANCELLATION OF REGISTRATION:** If a registrant needs to cancel their registration, the request must be made to [ashley.adams@nc3.net](mailto:ashley.adams@nc3.net) 30 days prior to the event. If the request is made more than 30 days before the event, the registrant will receive a full refund (if applicable). If the request is made within 30 days of the event, the registrant will forfeit their registration and will not be issued a refund (if applicable).
- VII. **EVENT CANCELLATION / POSTPONEMENT:** NC3 reserves the right to cancel or postpone this event due to low registration, natural disasters and/or any other circumstance(s) which would make the event non-viable. If the event is canceled, registrants will be notified via the contact information they provided in their registration form and will have the option to either transfer registration to a later NC3 Annual Leadership Summit or receive a refund. If the NC3 Annual Leadership Summit is canceled for any reason, you agree not to hold NC3 or any of their affiliates, employees, contractors, or industry partners liable for any cost(s) that may arise in association with your travel expenses nor any fees that may incur due to the event's cancellation; this includes but is not limited to a loss of funds due to hotel cancellations, flight cancellations, rental car reservations, etc.
